HOW TO USE
DO NOT apply inside buildings. Searles Dead Ant Pro is dispensed directly from the pack. Searles Dead Ant Pro will not harm soil or plants when used as directed. Use with caution around pets. Re-apply as necessary.

AREAS	PESTS	HOW TO APPLY
Buildings, Foundations, Pavements, Lawns, Gardens, Paths, Around Soil and Plants	Ants	Determine areas where ants are most active. Dispense directly from pack, sprinkle evenly over the area to be treated. Do not heap granules. Sweep in between pavers, cracks and crevices and disperse into soil and lawn. Where possible sprinkle directly on and around ant nests and trails. Heavy infestations rate: 250g/10m ² Light infestations rate: 75g/10m ² Reapply when ant activity returns.

CAUTION
Lock in a safe place preventing access by children or animals. Keep away from domestic pets, especially dogs. If dogs eat Searles Dead Ant Pro it may have toxic effects. If your dog eats Searles Dead Ant Pro contact your veterinary surgeon immediately.

DO NOT spread granules directly onto humans, pets, exposed food, food preparation areas or food utensils. Use with caution around pets. Ensure product is well dispersed i.e. sweep in between pavers, cracks and crevices and dispersed into soil and lawn. **VERY TOXIC TO FISH AND AQUATIC ENVIRONMENT.** DO NOT allow chemical containers or granules to get into drains, sewers, streams or ponds.
