

**Systemic control of Black Spot, Powdery Mildew and Rust. Kills aphids, thrips, caterpillars, budworm and mites on roses and ornamental. Works via contact and stomach action.**

**HOW TO USE**

- DO NOT mix with other insecticides or fungicides.
- DO NOT apply if rain is expected within 24 hours.
- DO NOT apply when shade temperatures are 30°C or higher.
- DO NOT apply when soil is dry and plants are suffering from moisture stress.

Commence spraying when new shoots sprout in Spring or at first sign of insects or disease. Repeat at 14 day intervals if required. Two-spotted Mites may require more frequent applications.

**HOW TO PREPARE:**

Shake bottle well. Remove child resistant cap from top of bottle. Measure out required amount and mix in water. Replace child resistant cap.

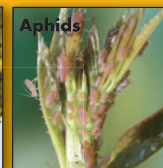
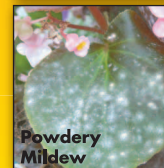
